#### Great questions to ask:

- Is my student on track to graduate? Failing classes at any time can put students off track for their 4 year graduation. Parents of seniors, these are important conversations!
- How is my student's attendance? The number one cause of not being successful in class (or the workforce) is not attending! Don't assume--find out what your student's attendance is all about!
- Is my student eligible for sports? Is my student going to be able to participate in Winter or Spring sports with the grades he/she currently has? Remember that a student must pass at least 5 classes AND can only fail one (1) class. Now is the time to get those assignments turned in and study for upcoming quizzes and tests.

#### **Sports Registration for Winter Sports**

We are still working on our FAFSA. What is FAFSA?

To apply for federal student aid, such as federal grants, work-study, and loans, you need to complete the Free Application for Federal Student Aid (FAFSA). FAFSA gives you access to the largest source of financial aid to pay for college or career school. In addition, many states and colleges use the student's FAFSA information to determine his or her eligibility for state and school aid, and some private financial aid providers may use the student's FAFSA information to determine whether the student qualifies for their aid. The Greeley Central Senior team is still helping our families complete this important step. Please reach out to them to make an appointment.

All senior students should have received an email invitation to join our senior class Google classroom which was sent to their school email. Please be sure that you accept the invitation, we will be updating it daily and sending important information this way.



At the end of October we took the ASVAB which with a score of 31 or higher checks off the new additional graduation requirements for both Math and English. One focus right now is working with students who struggled in classes last year to try and get grades up so they can graduate on time at Central. #### Junior:

My name is Kendra Villarreal. I am super excited to be the Junior Counselor! It is exciting to be looking forward to graduation and accomplishing future goals with the class of 2021!

Currently, we are talking about career plans and ensuring our Juniors have completed the new Graduation Guideline requirements set by the state of Colorado. Students need to achieve scores on tests that show competency in Math and English. Many of our juniors have accomplished this requirement by scoring a 31 on the ASVAB. The next opportunity will be taking the SAT test in April. Students must earn a 500 in Math and a 470 in English to reach this requirement.

To prepare, students can access free SAT preparation activities on <a href="khanacademy.org">khanacademy.org</a>. Test practice books are also available online or at local bookstores.



#### **ATTENDANCE**

To report an absence for your student please call the attendance line directly at (970) 348-5014.

Please also remember to bring a photo ID with you when you come to pick up your child. Although some staff may know the parents of students, not everyone in the office may be familiar with you or your child.

We require at least one (1) hour's notice to release students so please plan ahead.

Please note that during testing, field trips, or athletic events, your student may initially be marked absent until later that afternoon. Attendance for some testing or school events is delayed due to receiving final student attendance lists from the testing rooms or field trip chaperones/coaches. #### **PARKING ISSUES**

Please be aware of where you are parking in each of the parking lots. There have been instances where emergency vehicles have needed to access the school and cars have been illegally parked in the lots, making it impossible for these vehicles to get where they need to be.

We realize that with the larger student population this year it is tougher to find available parking spaces. Please remember that in order to keep the flow of traffic through the parking lots, everyone needs to adhere to all parking signs and lines.


With the increased number of illegally parked vehicles this year, from this point on (April 5th, 2019), our School Resource Officers from the Greeley Police Department will be issuing tickets for those cars parked illegally.

#### STUDENT DROP-OFF

Please drop students off at the West entrance (student parking lot) in the morning for school. This parking lot is designed for a better flow of traffic. The Faculty parking lot (located on the North side of the building) is not designed for high-volume traffic and by trying to drop your student off at the North doors creates a bottle-neck on 15th Street and in the parking lot itself.

The West entrance (student parking lot) creates a safer area for your student to get into the building rather than having them walk across 15th Street in traffic. Thank you for your attention to this as we strive to keep the area safe for not only your student but for you as well

We will be blocking off the Faculty parking lot in the mornings and afternoons to try to eliminate this bottleneck. Please do not stop in the middle of the street (15th Street) to let your students run across traffic. This is not safe and is not legal. Please use the student parking lot for dropping off students.



#### Notes from the Health Office:

#### Flu season is right around the corner...

- The CDC recommends that everyone 6 months and older get vaccinated this season.
- Here are some other tips for staying healthy:
  - Wash your hands with soap and water frequently during the flu season.
  - o Avoid touching your eyes, nose or mouth.
  - Cover your mouth or tuck it into your elbow when coughing or sneezing.
  - o Avoid contact with people who are sick.


#### **Regional Cross Country and State Qualification**

#### **Colorado Higher Education Admission Requirements**

Students planning to attend a four-year college or university in Colorado will need to complete the following classes in order to fulfill the Higher Education Admission Requirements. In addition to the Higher Education Admission Requirements, students must also meet the **Admission Eligibility Index**.

Meeting the Higher Education Admissions Requirements does not guarantee admission to a four-year public institution. Colleges and universities may have additional requirements.

Dear Wildcat Families:



November 5 is a very important election day for Greeley-Evans School District 6, and I want to be sure our families have the factual information they need to make an informed decision at the polls.

A Citizen's Task Force asked the District 6 Board of Education to place a bond issue on the November 5 ballot. This ballot measure asks voters in Greeley and Evans to approve a \$395 million bond issue that can be used for building improvements, repairs and renovations, as well as equipment and furniture. It cannot be used for salaries or programs.

It has been 17 years since District 6 has built any additional schools, and, in nearly the same time, the district has grown by 7,000 students. District-wide our schools are 5,000 students over capacity, and 142 of our classrooms are portable buildings.

Overall, this bond issue will help District 6 to begin to address overcrowding and plan for future growth. Five schools have been recommended for demolition and a complete rebuild: Greeley West High School, Madison Elementary School, Scott Elementary School and Brentwood Middle School. The first two--Greeley West and Madison--will be demolished and rebuilt as larger schools with more capacity. As well, a new K-8 school will be funding to provide additional classrooms and relieve overcrowding.

Large additions will also be constructed at McAuliffe STEM Academy K-8 and Chappelow Arts Magnet K-8. Both schools are significantly over capacity and facilities such as gymnasiums, cafeterias and performing arts spaces are not adequate for the number of students.

If 4C is approved by voters, every school in District 6, including charter schools, will receive money for repairs and renovations, like heating and cooling upgrades, roof repairs, carpet replacement and asbestos abatement, paint in critical areas and improvements for accessibility to comply with the Americans With Disabilities Act. Every school will also receive money for upgrades to safety and security, including safe entryways at all schools and improved door hardware for interior doors.

Also, each school will be provided funding for instructional upgrades to be determined through a collaborative process that will include the school community. Improvements could include STEM labs, project-based learning spaces, furniture, classroom modifications, fine arts equipment

and supplies, health and wellness equipment and spaces, or other capital improvements that support career and technical education programs.

I have again included the flyer that talks about how much our schools will receive from Bond Issue 4C. I ask that you take a minute to review this, and if you have any questions, please let me know.

El 5 de noviembre es un día de elecciones muy importante para el Distrito Escolar 6 de Greeley-Evans y quiero asegurarme que nuestras familias tengan la mayor información que necesitarán para poder tomar una decisión informada al votar.

Un comité conformado por ciudadanos solicitó a la Mesa Directiva del Distrito 6 que colocara una propuesta "bond issue" en la papeleta electoral del 5 de noviembre. Esta medida electoral pide a los votantes en Greeley y Evans aprobar una propuesta de \$ 395 millones que podrán usarse para hacer reparaciones, mejoras y renovaciones de edificios escolares, así como también a equipos y muebles. No podrá usarse para salarios o programas.

Han pasado 17 años desde que el Distrito 6 construyó escuelas nuevas, y en ese mismo lapso de tiempo el distrito ha tenido un crecimiento de aproximadamente 7,000 estudiantes. En todo el distrito, nuestras escuelas tienen un sobrecupo de más de 5,000 estudiantes y 142 de nuestras aulas son edificios portátiles.

En general, esta propuesta ayudará al Distrito 6 a empezar a resolver el problema de sobrecupo y a planificar para el crecimiento futuro. Se nos ha recomendado que cinco escuelas sea derrumbadas y se vuelvan a reconstruir en su totalidad: la Escuela Preparatoria Greeley West , Escuela Primaria Madison, Escuela Primaria Scott y la Escuela Secundaria Brentwood. Las dos primeras, Greeley West y Madison, serán derribadas y reconstruidas como escuelas más grandes y con mayor capacidad. Así también, se utilizarán estos fondos para construir una escuela nueva K-8 que proporcionará aulas adicionales y resolverá el sobrecupo.

También se harán adiciones importantes a la Academia McAuliffe STEM K-8 y Chappelow Arts Magnet K-8. Ambas escuelas tienen un sobrecupo significante y las instalaciones de sus gimnasios, cafeterías y espacios de artes escénicas no son adecuadas para la cantidad de estudiantes.

Si los votantes aprueban la propuesta 4C, todas las escuelas del Distrito 6, incluyendo las escuelas chárter, recibirán fondos para reparaciones y renovaciones, tales como mejoras a los sistemas de calefacción y aire acondicionado, reparaciones de techos, reemplazo alfombras y remover asbesto, pintar donde sea más necesario y mejoras para la accesibilidad en conformidad con la Ley de Americanos con Discapacidades. También cada escuela recibirá fondos para mejorar la seguridad, incluyendo la seguridad de entradas en todas las escuelas y cerrojos y equipo de las puertas interiores.

Además, cada escuela recibirá fondos para actualizar la instrucción; esto se determinará mediante un proceso colaborativo que incluirá a la comunidad estudiantil. ## **Arguments for:**

- Greeley-Evans School District 6 schools are currently 5,000 students over capacity district-wide.
- District 6 has not constructed any additional, non-charter schools since 2003. The District has grown by 7,000 students in the past 20 years.
- The money from this ballot measure will provide much-needed funding for repairs and renovations of public schools, including charter schools.
- This ballot issue will also begin to address capacity issues by constructing a new K-8 and adding capacity to some schools.
- The State of Colorado does not provide specific funding to school districts for capital improvements, including new schools, major renovations and repairs, upgrades to security and safety, upgrades to systems such as heating and cooling, or renovations for programs. The only funding available for capital projects comes through state grants, which require significant matching funds and don't cover all needs.
- It is the responsibility of District 6 and the community to do everything possible to ensure students and staff are safe. This measure would pay for additional security measures, such as safe entryways, updated locks and door hardware and the removal of some portable buildings.
- A Bond Oversight Committee will be appointed to ensure that District 6 uses the money from the Bond to fund programs and learning opportunities as promised.

## **Arguments against:**

- Taxes should not support schools because they only serve students, which is a small segment of the population.
- This measure would increase property taxes. Due to the Gallagher amendment, this puts a larger burden on business owners in the communities of Greeley and Evans.
- District 6 doesn't need additional revenue. It should make cuts to fund facility needs.
- There is not sufficient accountability or oversight on how this money will be used.
- It is the responsibility of the state to fund public education. This measure asks local property owners to take on some of that responsibility.
- Some may not agree with how District 6 has spent its money to this point, and believe there is room for better financial management.
- District 6 should find money from other sources, such as charitable organizations and grants.

## **Argumentos a Favor:**

- A nivel distrito, las escuelas del Distrito Escolar 6 de Greeley-Evans actualmente tienen un sobre cupo de 5,000 estudiantes a nivel distrito.
- El Distrito 6 no ha construido ninguna escuela adicional, aparte de escuelas chárter desde el 2003. En los últimos 20 años el Distrito ha tenido un crecimiento de más de 7,000 estudiantes.
- El dinero recaudado de esta propuesta en la papeleta electoral proporcionará fondos muy necesarios para reparaciones y renovaciones de escuelas públicas, incluyendo las escuelas chárter.


## **Argumentos en Contra:**


